Since '94, JFA has provided a pro bono network for uninsured musicians in health crisis. Dizzy Gillespie was a patient at Englewood Hospital in New Jersey many times before his passing in early 1993 from pancreatic cancer. Dizzy expressed two wishes to his family in his last days: to support the greatest passion in his life—jazz and jazz musicians—and to have a memorial in his name at "his" hospital, Englewood Hospital and Medical Center. The JFA carried Dizzy's torch with aplomb. The Dizzy Gillespie Memorial Fund helps underwrite the costs of hospitalization, diagnostic tests, and a full range of surgical and medical care for jazz musicians who are uninsured and without the ability to pay. The Dizzy Gillespie Cancer Institute at Englewood Hospital has grown into a world-renowned oncology center, recognized as a model for cancer diagnosis and management. Since its formation, the Memorial Fund, which is 100 percent donor-supported, has provided over \$9 million in medical services to more than 1,900 of JFA's blues, jazz, and roots musicians who otherwise would not have been able to afford healthcare. Over 24 years, Englewood Hospital has never turned away a sick musician, and its unprecedented generosity has literally kept the music alive. This program has thrived and grown thanks to the leadership of Dr. Frank Forte, Dr. Steve Brunnquell, Eddie Hadden, Mike Pietrowicz, Doug Duchak, Bob Litwak, and the 50 physicians who donate their time and energy annually to JFA patients. Since 2001, this network of amazing doctors has grown to other states where we have found uninsured musicians who need help. These doctors have opened their hearts and their care to our musicians in times of crisis. Additionally, we have created a network of dentists and oral surgeons who either donate their services completely free or at deeply discounted rates. These services are available to horn players and vocalists as the dentists' time and caseloads allow.

The Musician Treatment Foundation (MTF) provides surgical and related care for the shoulder, elbow, and hand injuries of under- and uninsured professional musicians so they can maintain their livelihoods and keep the music playing for us all. MTF is dedicated to fostering a world that cares for its injured musicians regardless of their ability to pay. On average, professional musicians spend over 90% of their time performing live on the road, away from personal and medical support systems. Injuries

can arise at any moment from the repetitive intensity of playing instruments, and from unexpected accidents. With this in mind, we are launching the first nonprofit of its kind – in design, scope, and breadth – to fund and facilitate upper limb treatment and continuity of care for needful musicians at home and on tour.

Since MTF's establishment in Austin last year, it's provided \$565,000 worth of free medical care to musicians—making it just the latest organization to try to crack the city's musician welfare problem. But even with its growing Rolodex of do-gooders, the Live Music Capital of the World is still struggling to keep the show going. Affordability continues to be an ongoing issue—one that's hardly confined to Austin's musicians—and consistent streams of revenue have been difficult for artists to access, especially in the era of digital streaming and low music sales. According to HAAM's most recent reports, more than 60 percent of its members are barely making enough money to get by every month.

Costs and pricing are designed to be reasonable for both patients and providers of care. SightLife, a 501(c)(3) nonprofit (formerly the Northwest Lions Foundation (NLF)) designed and developed the AUDIENT Alliance after many years of experience coordinating the activities of the Lions hearing aid recycling program for the Pacific Northwest. A committee of nationally recognized hearing care professionals advised NLF during the development stage.

As would be true for any health problem, the patient undergoes a detailed history and examination geared toward the particular symptoms reported. The musician is asked to bring his/her instrument (a piano is available on site) and an integral part of the evaluation is observation of the instrumentalist while playing. The entire range of consultations, diagnostic tests, and therapeutic modalities is available at our disposal to provide a comprehensive assessment and treatment program designed to return the instrumentalist to full playing activity, if possible. Over 1500 instrumental musicians have been evaluated and treated for neurological conditions in the Department of Neurology's Center for Performing Artists since its inception.

**Background:** Princeton University economics professor Alan Krueger likes to joke that E Street Band drummer <u>Max Weinberg</u> is the only man alive who can say he's shared a stage with <u>Bruce</u> <u>Springsteen</u> and the former chairman of President Barack Obama's Council of Economic Advisers.

Krueger, who met Weinberg and Springsteen during the course of researching a ticketing study, happily accepts the suggestion he's a numbers-crunching wonk with a rock 'n' roll heart. He's also the first to admit that while it was an honor and privilege to serve Obama and the country trying to turn around the worst recession since the Great Depression, he's glad it's over.

Now, Krueger is turning his attention back to his first love: crunching data around all things music. Readers may remember his presentation on the economics of concert tickets at the Concert Industry Consortium – predecessor to Pollstar Live! – in 2002, and follow-up studies on secondary ticketing he's shared with *Pollstar* over the years.

Krueger, with the help of Jeannie Wilkinson, Live Nation's former VP of Global Research, has established the <u>Music Industry Research Association</u> and is preparing to launch Aug. 10-11, 2018 what is hoped to be an annual conference for music industry professionals, taking place on the <u>University of California, Los Angeles campus</u>.

Read our musician-friendly articles. <u>Make an appointment</u> to get personalized advice from health insurance experts who are also musicians and understand how the health insurance landscape has changed with the implementation of the Affordable Care Act. We see this project as a safety net for those musicians who remain uninsured because of lack of support or clear information. Those musicians who reach out for help will get it. With this small step we hope to bridge the gap between confusion and need.
